The Board of Trustees for the Town of Log Lane Village met on Wednesday, September 13th, 2023, at 202 Birch Street, Log Lane Village Town Hall. Present were Mayor Naomi Zuniga; Board of Trustees present were Trustees: Cheryl Thoresdale, Norma Molina, John Vagher, Robin Mastin, and Josie Lopez-Rodriguez. Trustee Angie Vick was absent. Staff members present: Assistant Town Clerk Deb Lee, Officer Pedro Malave and Public Works Mike Fisher. Town Attorney Amy Penfold was present via Zoom.

Called to Order

Mayor Naomi Zuniga called the meeting of the Board of Trustees of Log Lane Village to order at 6:34 p.m. Roll call was taken, and a quorum was met.

Pledge of Allegiance

All present stood for the pledge of allegiance to the flag of the United States of America.

<u>Citizens Comment</u>: Anne Covelli from 100 Pine Street spoke asking what the protocol for people coming into her yard at night. Sunday, someone was beating on her door at midnight. She said two weeks ago someone was walking around her yard. She said she contacted dispatch, and they told her that Officer Malave was on duty and would be notified, but no one showed up. Officer Malave stated he wasn't on duty for that night. He explained that dispatch contacts the officers; the officers go check out the situation and then contact the person that contacted dispatch. She said the cement around her meter pit was broken up and Public Works must have done that. Mike Fisher, Public Works, let her know that they checked her meter, they did not break up the cement around it. It is her responsibility to fix the broken-up cement. She proceeded to tell Mike that he broke the cement up. Mike said he would check it, but public works did nothing to break up the cement.

Danielle Daniels from 133 Maine said that when the Town was fixing waterlines, she asked the workers to save her gravel and replace it when they were done. Mike said he will check with CDOT, but he doesn't believe that CDOT wants the gravel where she has it. Danielle stated that it's four feet from her house and there is now a huge crevice on the south side of her house. Mike asked if she meant east side. She said the crevice floods down the street. Mike said he will look at it.

Mayor Zuniga called up Salvador Lara, 220 Linden to ask him about his issue. He said he wants to bring in a new house, but it was built in 2000. He wants to know if he can still bring the older house in as it looks really nice on the outside. He gave the Mayor pictures to look at and show the rest of the board. Amy Penfold, Town Attorney, stated that a notice needs to be put on the property and we need a public hearing prior to allowing the house to be brought in. The Mayor told Mr. Lara that the issue will be tabled until next month so that we can have the public hearing.

Public comment was closed.
